The list of appointed Data Processors is continually updated and available at the offices of the Data Controller by writing to ucimu@ucimu.it. The provided personal data may be transferred to third countries, within or outside the European Union, within the limits and the conditions, pursuant to Articles 44 and following of GDPR, in order to comply with the purposes related to the same transfer.
